Traders Rules for the Stamp Exhibition 'Nationale Gouda 2019'

Article 1: Definitions

These Rules are applicable for the Stamp Exhibition 'Nationale Gouda 2019' of 18 – 20 April 2019 at Sportcomplex De Mammoet, Calslaan 101, 2801 RT Gouda and also on April 17th, the day of the built up.

The exhibition (approx. 700 frames) is organised by the Stichting Filatelistische Evenementen at Gouda, hereafter referenced as organising committee. The General Exhibition Rules are also applicable.

Article 2: The exhibition

The exhibition will be opened: Wednesday evening April 17 2019 from 18.00 until 21.30 h. (only for the participating traders, exhibitors and donors!)

Thursday April 18 2019 and Friday April 19 2019 from 10.00 until 17.30 h.

Saturday April 20 2019 from 10.00 until 16.00 h.

The exhibition holds a Rank 1 and 2 exhibition with international participation.

On Friday April 19 2019 there will be a festive Palmares evening at Hotel Van der Valk Nieuwerkerk a/d IJssel (at 12 minutes by car from De Mammoet) from 18.00 until 22.00 h. The fee amounts € 50; refreshing drinks, beer, house wine and inland spirits are included. The number of seats is restricted, so be in time with your reservations.

Article 3: The Organising Committee

The organising committee will take care of proper guarding and security. The participant needs to take care of its own insurance.

The organising committee and or its co-workers decline every responsibility for damage, lost or theft, whatever the cause may be.

Article 4: Application and Admission of Stand Participation

Application for stands need to be made in written (by letter or mail), preferably before December 1st 2018. The assignment will be made at latest on December 31 2018. January 15 2019 at latest the participation bills will be sent by email. Payments need to be made within a fortnight from date of invoice. Your application will be definitive at the receipt of your payment. Admission of a space will be made by the organising committee. We will reckon with your requests as much as possible. Any request for stand space solely will not be dealt with.

All tables will be provided with a tablecloth and three chairs per 2 meter and will be places along one of the walls of the venue. Smoking is not allowed inside the building.

It is not allowed to attach anything to the walls which can't be removed without leaving any traces on the wall.

The participant is responsible for any damage he might have caused. The stand needs to be empty and clean at the end of the exhibition.

The stand fee will be:

Traders:

2m: € 115 / m 4 – 6m: € 90 / m 8 and more: € 80 / m

These fees are for the total exhibition time starting Wednesday evening until Saturday afternoon. There is a minimum of 2 meters. Tables are exclusively available in multiples of 2 meters.

Specialized societies:

One table of 2 meter will be available for free under the next mentioned conditions: The table needs to be populated from Thursday up to Saturday inclusive with no interruption during opening hours. No trade is allowed, except selling of literature issued by the union itself.

Your application needs to be sent before December 1 2018. After this date no table can be guaranteed. You'll receive a bill of € 50 during January 2019, which needs to be paid before March 1 2019. This payment will make your assignment definitive, This deposit will be reimbursed within four weeks after the exhibition if you have complied with our conditions.

Other non-commercial participants

A table of 2 meter is available for € 100 for this event. The table needs to be populated from Thursday up to Saturday inclusive with no interruption during opening hours. No trade is allowed, except selling of your own products.

Article 5: Visitors

There will be no entry fee for the Exhibition nor the Stamp Show, except for the regulation on the 17th of April as stated before. The price of the catalogue will be set at a later moment.

Except in the explicitly indicated halls no trading or exchange of philatelic material is allowed in the complex, nor at the precincts. Trading nor barter in the indicated halls is only allowed by traders who have paid their participation fee to the organizing committee.

At the stands of the specialized unions, which have no participation fee, trading is not allowed under any circumstances, other than literature which is issued by these unions.

Smoking is not allowed anywhere at the complex.

The organizing committee is entitled at any time to refuse the admittance of unwanted visitors and can enforce them to leave if they are already present.

Article 6: Stand participators

The Stand participator has sent an application for a stand, has been admitted by the organizing committee and has paid in time according to the invoice.

Subtenancy of stands is strictly forbidden.

Under no circumstances entry fees for stands will be reimbursed, unless a written withdrawal has been received by the organizing committee ultimately two months before the Nationale 2019.

Traders are responsible for their own insurance. There is an alarm with direct report to an alarm centre in both halls.

A trader will receive one ticket for the evening of the 17th of April. This ticket is personal and not transferable. At withdrawal the ticket is no longer valid. A second ticket can only be granted by the organizing committee on that evening for a second person if this person is effectively present at the stand together with the trader. This second ticket will be withdrawn if this is not the case. Extra tickets are available for donators at the price of € 30.

Article 7: Conclusive regulations

The organizing committee can deviate from these rules in special circumstances as long as this is not contrary the rules of the exhibition regulations of the KNBF.

In cases in which these regulations have not foreseen, the board of the Stichting Filatelistische Evenementen decides.
